We , Eros International Media Limited ("Eros"), having our office at 901/902, Supreme Chambers, off Veera Desai Road, Andheri West, Mumbai 400053 hereby state that, Eros and **Novex Communications Private Limited ("Novex")** having its office at B/301, Remi Biz Court, Plot No. 9, Shah Industrial Estate, Off. Veera Desai Road, Andheri (West), Mumbai-400053, have executed a Deed of Partial Assignment Agreement dated February 9, 2017 and addendums thereto (collectively '**Agreement**') under which Eros has assigned to Novex, the On Ground Performance Rights of the songs/sound recordings in the films (listed in the Agreement) which are owned and acquired by Eros for the period commencing from **April 1, 2022 upto March 31, 2023 (Term)** in India for On-Ground Performance Rights and entire world for Ship Rights.

In view of such **On Ground Performance Rights** granted by Eros to Novex under the Agreement for the Term, Novex has the right to public performance/communicate to public, the songs/song recordings in the films (listed in the Agreement) on an "as is basis" across various ground based events and venues including but not limited to malls, pubs, hotels, etc. or any other place accessible to public with or without payment of entrance fees.

By virtue of 2nd addendum to the Agreement dated May 23, 2019, with effect therefrom Novex has been granted **Ship Rights** for the Territory of the World under the Agreement on an exclusive basis. It will encompass the same meaning and same rights: e On-Ground Public Performance Rights, and World Cruise and Ship Rights.

"Ship Rights" as defined under the Agreement shall mean the right to exploit the Sound Recordings on ships of any country or any water transport vessels in any river, sea, oceans or other water bodies in any part of the World by way of communication to the public at restaurants, bars, lounges and other public areas within such ships.

In view of the above, Novex as the exclusive owner of the Ship rights in and to the sound recordings shall also have the rights to prevent the unauthorized use of copyright in the Sound Recordings of the Songs contained in the Films and/or Albums of **EROS** and further has the right to initiate appropriate legal proceedings at its own costs against any person(s) or entity(ies) who may make such unauthorized means for the purpose as stated hereinabove.

It is however clarified that the rights granted under the Agreement are subject to Novex's compliance of its representations, warranties and obligations under the Agreement read with the addendums thereto and all other applicable terms and conditions of the Agreement.
