



TO WHOMSOEVER IT MAY CONCERN

We, **RED RIBBON ENTERTAINMENT PVT LTD** (“**RED RIBBON**” or “**We**”) have entered into Assignment Agreement with **NOVEX COMMUNICATIONS PRIVATE LIMITED** (“**Novex**”) vide Assignment Agreement dated 24th Day of March, 2022 (said agreement) wherein we have transferred and assigned on exclusive basis the **On Ground Performance Rights** in respect of the Songs/Sound Recordings contained in the Films and/or albums which are part of the repertoire of **RED RIBBON** to **NOVEX** for the term commencing from **1st April, 2022** and ending on **31st March, 2025** (both days inclusive) for the territory of India only and **Ship Rights** for the term commencing from **1st April, 2022 to 31st March 2023** (both days inclusive) for the territory of World. Novex vide said Agreement shall be entitled to grant licenses to any third party (as defined below) only in respect of **On Ground Performance Rights** and **Ship Rights** pertaining to the songs/Sound Recordings from the Films and/or albums which are a part of the repertoire of **RED RIBBON** for the term and territory herein. Novex as the owner of the On Ground Performance right and Ship right in the Sound Recordings shall have the right to issue licences for the said On Ground Performance and Ship Right in the Sound Recordings in its own name and also to collect license fees against the same in its own name.

“**On Ground Performance**” for the purpose of this Authorization Letter shall mean public performance/communication to public of the songs/sound recordings from the films and/or Albums which are a part of the repertoire of **RED RIBBON** during the term and within the territory as mentioned hereinabove across various ground based events and venues including but not limited to malls, pubs, hotels, etc. or any other place accessible to public with or without payment of entrance fees.

“**Ship Rights**” for the purpose of this Authorization Letter shall mean the right to exploit the Sound Recordings on ships of any country or any water transport vessels in any river, sea, oceans or other water bodies in any part of the World by way of communication to the public at restaurants, bars, lounges and other public areas within such ships.


“**Third Party**” for the purpose of this Authorization Letter shall mean the party interested to secure license for the song(s). Third parties for the purpose of this Authorization Letter shall mean and include commercial establishments including without limitation to hotels, restaurants, discotheques, casinos, college campuses, event companies, DJs, cinemas halls, shows, malls, stores, shops, salons, parlours, religious events, marriage halls (except the religious events/marriages etc exempted as per the act), railway and bus stations, airports, buses, cabs, taxis, airports, ships, cruise liners, motels, guests houses, banks, offices, clinics, amusements parks, clubs, private shows, fashion shows, exhibitions, Banquet halls, Palace, Resorts, and Hotels and any other public areas.

Novex as the owner of the On Ground Performance right and Ship Right in the Sound Recordings shall also have the rights to prevent the unauthorized use of copyright in the Sound Recordings of the Songs contained in the Films and/or Albums of **RED RIBBON** and further has the right to initiate Civil and/or Criminal proceedings against any person(s) or entity(ies) who may be make such unauthorized means for the purpose as stated hereinabove.

We, further state that **RED RIBBON** has granted the On Ground Performance Rights and Ship Rights in the Sound Recordings exclusively in favour of **NOVEX** and no other entity has been the On Ground Performance Rights and Ship Rights in the Sound Recordings.

This authorization is valid from **1st April, 2022** and ending on **31st March, 2025** for the entire territory of India.
