# PM Modi to visit Palestine: Envoy to India

## PALESTINE ENVOY WITH SAIED

MEAs said India's concerns "were conveyed both to New Delhi and to the Palestinian ambassador and to Ramallah to the minister of Palestinian affairs and executives".

In a statement, the MEA said the Palestinian side has conveyed "deep regrets" over the incident and assured that they are taking serious concerns of their ambassador's presence at this event. "They have said they will deal with this matter appropriately".

Prime Minister Narendra Modi is expected to travel to Palestine in the coming months. "I cannot disclose the exact date, but I can confirm that Mr Modi will travel to Palestine", Al Habba said. The visit would follow the government's decision to de-hyphenate the two relationships (With Israel and Palestine) with a goal to either not necessitating a halt to the neighbourly state. The Indian government said it had been assured by Palestine that they would not "engage with those who commit acts of terror against India".

# Brigadier's wife had complained to his seniors

The OIC, being held at Durgam Chattrani in the Indian-bred Eastern Army Command and headed by a Major-General, this week imposed the fresh stringent punishment on the Brigadier. An officer contacted from services has said, depositions and all relevant details.

"Really the allegations of a brother officer's wife" — complement for a senior officer — is considered a serious crime in the armed forces because it hits at the very foundation of brotherhood and loyalty fostered in the military where husbands often leave their wives behind to be "renewed" — formally, accommodation in camps — on assignments on the forward or field areas. OICs are allowed for such offences usually summarily sacked, mostly without pension and other benefits.

The Army had instigated a court of inquiry (COI) against the Brigadier after his wife, a principal of a prominent school in New Delhi, had complained of his extra-marital affair to his seniors. In the subsequent court martial, headed by a Major-General and including six Brigadiers, the OIC was found guilty on 13 charges, including adultery with a superior officer, gross misconduct and violation of government and military discipline.

He later pleaded guilty after his wife submitted WhatsApp messages exchanged between him and the Colonel's wife.
