



**TO WHOMSOEVER IT MAY CONCERN**

We, Sai Productions ("We") have entered into an Agreement with Novex Communications Private Limited ("Novex") vide Deed of Assignment Agreement dated 01/09/2021 ("Agreement") wherein We have assigned on exclusive basis the **On Ground Public Performance Rights** (as defined below) to the sound recordings in respect of the Songs as mentioned in **Schedule I** of the Agreement, and all forthcoming songs added to the Schedule I during the tenure of the Agreement ("Songs") to **Novex**, for the term commencing from **15<sup>th</sup> September, 2021** and ending on **14<sup>th</sup> September, 2026** (both days inclusive) ("Term") and for the territory of **India only** ("Territory").

Novex vide the Agreement shall be entitled to grant licenses, as per sections 30 read with section 18(2) of the Copyright Act, 1957, to any Third Party (as defined below) only in respect of **On Ground Public Performance Rights** (as defined below) of the sound recordings of the Songs, for the Term and Territory. Accordingly, Novex as the exclusive assignee of the On Ground Public Performance Rights shall have the right to issue licenses for the said On Ground Public Performance Rights to the sound recordings in its own name and also to collect license fees against the same in its own name.

"**On Ground Public Performance Rights**" shall, mean the right of making available or communicating the sound recording of a Song, to the public, for being seen, heard or otherwise enjoyed as part of any physical on-ground activity or a live on-ground event where in the performance of the sound recording of a Song is given in public, including and not limited during live events, stage shows, award ceremonies, on-stage performances, dance performances, choreographed activities or other live physical event / activity, organized by any Third Party within clubs, lounges, restaurants, hotels, discotheques, bars, pubs, casinos, college campuses, corporate events, DJs, cinemas halls, shows, malls, stores, shops, salons, parlors, religious events, charitable functions, marriage halls, studios, railway, bus stations, and/or airports where any live on-ground events are organized, motels, guests houses, banks, offices, clinics, amusements parks, clubs, private shows, fashion shows, exhibitions, banquet halls, palaces, resorts, and hotels and any other public place where the sound recordings of the Songs can be played or made available for being seen, heard or otherwise enjoyed by members of public, in any on-ground / live event, regardless of whether any member of public actually sees, hears or otherwise enjoys the same, where such event is with or without payment of entrance fees to any such place.





**"Third Party"** shall mean the party interested to secure license for the On Ground Public Performance Rights of the Song(s). "Third parties" for the purpose of this Agreement shall mean and include commercial establishments including without limitation to hotels, restaurants, discotheques, casinos, college campuses, event companies, DJs, cinemas halls, shows, malls, stores, shops, salons, parlors, religious events, marriage halls, studios, railway, bus stations, and/or airports where any on-ground events are organized, motels, guests houses, banks, offices, clinics, amusements parks, clubs, private shows, fashion shows, exhibitions, banquet halls, palace, resorts, pubs, bars, lounges and any other public areas.

Novex as the exclusive assignee of the On Ground Public Performance Rights to the sound recordings of the Songs shall also have the rights to prevent the unauthorized use of copyright in the Sound Recordings of the said Songs, and further has the right to initiate civil and /or criminal proceedings against any person(s) or entity (ies) who make unauthorized use of the On Ground Public Performance Rights of the Songs.

We, further state that we have assigned the On Ground Public Performance Rights to the sound recordings of the Songs, exclusively in favor of Novex and no other entity has been assigned the On Ground Public Performance Rights to the sound recordings of the Songs.

This Authorization Letter is valid from **15<sup>th</sup> September, 2021** to **14<sup>th</sup> September, 2026**, for the entire Territory (i.e., for India only), unless the Agreement is terminated earlier in accordance with the terms of the Agreement.
